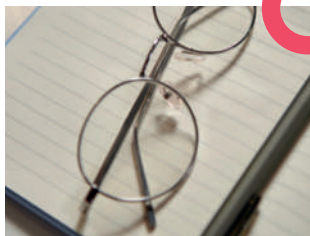

Transfer Students
